Minutes

- 0 Short self-introduction of participants
- 1 Adoption of agenda. No changes were requested for the minutes of the previous meeting at DACA-13 in July 2013.
- 2 Overview of IAMAS activities since IUGG-2011 (Appendix 1). No specific questions were raised.
- 3 IAMAS finances 2013-2015 (Appendix 2): Hans VOLKERT's report showed that the IAMAS accounts were in a good financial shape. Colin PRICE, the auditor, examined all three IAMAS accounts and found the account records clear and correct and suggested that some money should be spent on supporting young scientists to attend IAMAS-related events. Hans VOLKERT further explained, in response to Jo HAIGH's inquiry of

Hans VOLKERT further explained, in response to Jo HAIGH's inquiry of why the IUGG contribution to IAMAS income has gone down, that the total

amount of what IUGG received from its adhering bodies has declined. Some countries have not paid and some others want to pay less.

- 4 Ten commissions reported on their activities. (Appendix 3a-3j). Athena COUSTENIS urged commissions to interact more often and co-organize workshops and research activities.
- Australia (Appendix 4a), China (Appendix 4b) and France (4c) reported on selected atmospheric research activities in their countries. There is a common concern that atmospheric research, in particular climate change research in U.S.A., Australia and some European countries have not received sufficient support from national governments. Mike MacCRACKEN suggested having a resolution to address the issue. The draft resolution would have been discussed at the second EC meeting after drafts were circulated.
- 7 Guoxiong WU reviewed the work of the nominating committee and introduced the candidate slate for the IAMAS EC 2015-2019.

Minutes

- 1 The IAMAS Early Career Scientist Medal was presented to Dr. Yuan WANG by Athena COUSTENIS and Hans VOLKERT. The citation was read by the Chair of the committee, John TURNER. Then John TURNER described the current selection procedure and emphasized that each commission should review the candidates and only recommend one candidate to IAMAS EC in order to aid the work of the Awards Committee.
- 2 The financial report was approved as presented during the EC-1.
- 3 Reports were presented on the liaisons to SCAR (TURNER, Appendix 5a), SCOR (COUSTENIS, Appendix 5b), WMO (VOLKERT, Appendix 5c) and WCRP (BEER, Appendix 5d). All liaisons felt being an IAMAS representative to these organization is a rewarding experience. IAMAS's presence in most of these organizations raises the profile of IAMAS. Tom BEER suggested that the next person who takes over the liaison to WCRP should have very strong links to both organizations he/she represents. He also raised the question on the IUGG level if it should be more than one liaison from more than one association to other organizations. These questions will be discussed by the new IAMAS EC.

4 There were two additional items from EC-1

- -- Video archiving of presentations. Richard GROTJHAN introduced the rationale of having video archiving of presentations: more access to presentations, ability to review talks later, extends the visibility of IAMAS. and modernizing the operation of our assemblies. Athena COUSTENIS was concerned that the video streaming/archiving was costly and that it was not successful due to lack of exchange with the audience it entails. James DRUMMOND was concerned it would spoil the spontaneity of the presentation. All agreed that PDF archiving with author's copyright permission is easier, though there's less content than in the video. John BURROWS suggested registering DOI for each presentation to avoid non-published data being gained by one's competition. All agree that streaming is too big a step at this stage, but should be discussed in the preparations for the 2017 IAMAS assembly, probably starting with invited presentations first. Athena COUSTENIS requested further investigation into the issue. John BURROWS will contact the local organizer of the iCACGP2014 workshop to gain the hit counts of the videos. The new EC will consider it in the preparations for IAMAS2017.
- -- The IAMAS resolution on Encouraging National Support for International Scientific Organizations. Mike MacCRACKEN introduced the rationale of the resolution. The EC found the title was too broad and was not directly relevant to IAMAS. John BURROWS suggested it should be more specific, e.g. the danger of operational systems without associated science

infrastructure. Tom BEER, the chair of the IUGG Resolution Committee, emphasized that the draft resolution had to be submitted to the IUGG Resolution Committee by 8am on Sunday, 29 June if it was to proceed at this stage. Werner SCHMUTZ suggested that the resolution should be more of an IUGG issue. The EC voted and decided not to endorse the resolution in its current form and suggested the new president bringing it up at the IUGG EC council meeting and/or preparing the resolution for IAMAS2017. John TURNER suggested that in the future, it was advisable that draft resolutions be circulated at least one month before the assembly if possible.

- 5 Publication association opportunity with Advances in Atmospheric Sciences (AAS): Athena COUSTENIS introduced the rationale for this proposal: the other IUGG associations have their own journals to showcase their work and IAMAS would also like to have an associated journal to publish reports and special issues as the occasions arise. AAS has a title and purpose that fits with the goals of IAMAS and the Editors-in-Chief have also expressed interest. A presentation was given by Darren LU, Chief Editor of AAS. Having AAS as an IAMAS associated journal, the IAMAS logo will be on the cover of each issue of the journal. Athena COUSTENIS reiterated that there's no obligation for IAMAS members to publish in AAS even if it becomes the preferred IAMAS journal. Sanjay LIMAYE asked about the page charges and copyright issues and Jenny LIN and the AAS Editor gave some information. B. J. SOHN asked how long the cooperation between IAMAS and AAS would last and what benefits the IAMAS member can receive from cooperation. Matthew LAZZARA asked if AAS could publish workshop reports. James DRUMMOND would like the associated journal to be an Open Access journal. This was seconded by John BURROWS and Sanjay LIMAYE because it's the requirement from the funding agencies in their home countries to publish in an Open Access journal. John TURNER said there would be a Memorandum of Understanding (MOU) to document these issues. The EC then voted and approved the cooperation. The details will be discussed and agreed upon by the next Bureau.
 - 6 Guoxiong WU chaired the election of IAMAS EC for the period 2015-2019. Twenty two votes were received. John BURROWS, Jianping LI and Hans VOLKERT served as tellers. Guoxiong WU announced the newly elected EC members:

7 Updates from the IUGG EC and council meetings.

- -- Athena COUSTENIS commented that IAMAS has quite some interaction with other associations and union commissions. This is demonstrated by the joint meetings organized in 2013 and in 2017.
- -- IUGG is currently considering modifying its statutes and John TURNER will read the IAMAS statutes in detail and discuss possible revisions of the IAMAS Statutes in one or two years.
- 8 Future developments of IAMAS and role of Members-at-Large. John TURNER suggested establishing an informal development committee, and having more IAMAS awards, such as an Honorary IAMAS Fellowship. John TURNER also proposed that IAMAS have a higher profile on social media to draw young people into IAMAS. ICPAE, ICDM, ICACGP and ICAE reported changes of officers. Athena COUSTENIS asked commissions to send the updated coordinates of the new officers and full membership list with e-mails and affiliations to Jenny LIN by the coming Wednesday.
- 9 Planning for IAMAS-IAGA-IAPSO 2017. Isabelle ANSORGE presented the venue and logistics of the joint assembly and answered questions. John TURNER asked all commissions to submit symposium proposals by December 2015, including title, conveners, and descriptions.
- 10 Planning for IAMAS2021. John TURNER informed the EC that before Cape Town 2017, IAMAS needs to have received an expression of interest in hosting IAMAS2021. In addition a decision has to be made on whether IAMAS is going to have a joint assembly with other associations or a meeting on its own.
